Declaration of compliance with safety instructions during the stay in our forest bryony „Stromhouse“

I. Operator/Owner

II. Description:

Usage of the forest tree bryony „Stromhouse“ that is located in Pyskočely. The house is designed for maximum of 4people, including children.

Children must always be accompanied by adult who is fully responsible for them and their actions.

III. Safety instructions:

The following safety precautions while using the „Stromhouse“ are set by the owner/operator.

The declaration must be signed by each visitor that will be accommodated in the bryony „Stromhouse“ will be granted only upon signing the declaration.

It is mandatory

- Confirm that you have no medical condition (cardiac problems, vision problems, sleepwalking etc.) at the time of reservation or during the check-in.
- You are in possession of mobile phone device that is fully functioning and charged.
- All candles must be extinguished before bedtime or leaving bryony „Stromhouse“.
- Return all appliances / accessories that were provided to you at the check-in (return items to the responsible operator)
- In case of any damage or loss (non-compliance) you will be charged for the damage.
- You must report any discrepancies and damages that you notice during your stay in the bryony „STROMHOUSE“

It is forbidden

- No smoking inside the house. Throwing cigarettes butts, littering on the terrace and around the whole area.
- Using different type of light than those that are installed is not allowed (excluding the torch)
- Entering the house under the influence of alcohol or drugs is not allowed.
- We do not recommend to keep your valuables inside the bryony „Stromhouse“ In case of any loss we do not take any responsibility for your valuable belongings.

Weather conditions precautions

In case of bad weather conditions during your stay (thunder storm, wind gusts more than 90km per hour) the responsible person will issue a warning. If the guests fail to comply with the safety precautions and they decide to stay in the house, they will be fully responsible for their own safety. **Representative number +420 607 731 117**

Consent to the processing of personal data

Stromhouse processes the personal data of the registered entities that were provided to Stromhouse as part of the booking when booked in according with applicable laws of the Czech Republic, in particular the Personal Data Protection Act No. 101/2000 Coll. as amended.

Personal information is personal data provided when booking and purchasing gift vouchers, which are: name and surname, e-mail address, billing address, delivery address and phone number. By the Reservation at <https://stromhouse.cz> guest agrees with the processing and collection their personal data in the Stromhouse.cz database and they are not further provided to any other parties.

The provision of personal data is voluntary, but without it, the booking can not be completed successfully and the purchase of the voucher is possible only in cash after agreement at the Stromhouse office address.

A registered entity may at any time request the deletion of all personal data from the Stromhouse database. The Registered Entity has the right to withdraw consent to the collection and processing of personal data at any time also by e-mail address info@stromhouse.cz. Upon withdrawal of consent, all personal data from the Stromhouse database will be erased.
